# 85 Heads of Communists Are Indicted by US Jury: Charge is "Conspiracy to Cause Armed Revolution": Bonds Put at \$5,000 [events of Jan. 23-24, 1920]

CHICAGO.— Chicago authorities Saturday [Jan. 24, 1920] rushed plans to bring to trial here 85 leaders of the Communist Party indicted by a Cook County grand jury late Friday [Jan. 23]. The charge is "conspiracy to cause an armed revolution in the United States." Bonds are fixed at \$5,000 on each charge.

Among those named in the indictments were:

Mrs. Rose Pastor Stokes, now out on bond pending appeal to the Federal Court of Appeals at St. Paul of her conviction by the Kansas City federal court on three alleged violations of the espionage act. She is a member of the Central Executive Committee of the Communist Party.

Nicholas I. Hourwich, editor of the Novyi Mir.

Charles E. Ruthenberg, Cleveland, O., National Secretary of the Communist Party.

Louis C. Fraina, editor-in-chief of Communist publications.

Oscar Tyverowski, member of the national [Central] Executive Committee. Harry M. Wicks, member of the national [Central] Executive Committee, convicted last spring in Seattle of "criminal anarchy."

They were to be arraigned Saturday.
