- **District** 7 **Detroit:** Lower peninsula of MI; IN except for counties in D8.

- **District 8 Chicago:** IL as far south as the line from Danville to Quincy; WI as far north as Milwaukee; Indiana Counties: St. Joseph, Laporte, Porter, and Lake (i.e. the cities of Gary, Michigan City, and South Bend).

- **District 9 Minneapolis:** Upper peninsula of MI; MN; WI except for the Milwaukee area.

## Notes:

- 1. There were no Districts 11 and 14 at the time the material was printed.
- 2. The former District 11 was a short-lived Western District based in Denver that was dissolved in May 1922 due to insufficient membership. The district encompassed CO, WY, UT, MT, and ID.
- 3. There were two attempts at launching a District 14. The first in early 1922, based in Oklahoma City and encompassing AZ, NM, TX, OK, and AR. It was dissolved in May 1922 due to insufficient membership. The second was based in Wilkes Barre, PA, and including a number of Pennsylvania coal mining locales. It was in existence only during May and June of 1923.
- 4. There was a short-lived District 15 based in Atlanta in early 1922. It included the southern states of GA, AL, MS, LA, TN, KY, NC, SC, VA, and FL. It was dissolved in May 1922 due to insufficient membership.
