The Situation in Brief.

Briefly stated, the situation in Colorado at this time can be briefly summarized as follows: There had been an eight-hour law on the statute books which the supreme court had declared unconstitutional; a constitutional amendment making it obligatory for the leg-islature to enact such a law was adopted at the general election in 1902 by a majerity of 46,000 votes; the corporations of the state, by means of a lobby and the collusion of Governor Peabody, prethe collusion of Governor Peabody, pre-vented the enactment of the law. With this high-handed piece of lawlessness began the history of Colorado's shame, and the long list of crimes that follow are in harmony with such a beginning. The entry of The Western Federa-tion of Miners into politics, which had almost resulted in the enactment of a law disliked by the corporations made
